2. SCOPE OF LICENSE

Subject to your compliance with the terms and conditions of this EULA, the Licensor grants you a limited, non-exclusive, non-transferable, revocable license to use the mobile application, including any updates or upgrades provided by the Licensor, solely for your personal, non-commercial use.

You may not sublicense, sell, assign, rent, lease, loan, distribute, transmit, or otherwise transfer any rights to the mobile application or any part thereof. You may not reverse engineer, decompile, disassemble, or create derivative works of the mobile application, except to the extent that such activity is expressly permitted by applicable law.

The Licensor reserves all rights in and to the mobile application not expressly granted to you under this EULA. You acknowledge that the license granted to you is limited to a right of use and

is not a transfer of ownership or title in the mobile application or any intellectual property rights associated with the mobile application.
